Treasurer Report

- Opening balance \$102, 243.18
- \$75,000 in investments
- Balance- \$32,058.05
- Milk- close to \$9000 in revenue
- Spring hockey- over \$17,000 dollars
- Skaters given option to send etransfers instead of paying by credit card which made a big difference on fees
- Overall, good financial health

- Question: Are you saving for any more big expenses?- not currently, will discuss at next meeting (potentially cameras in arenas- discussion took place, discussion re internet in arenas- official complaint needs to be made to the County)

New Business:

Bylaws update- Jeff Barrett

- Had not been updated since 2012
- Took the year to clean up grammar etc, and reviewed each section
- It has been rewritten and updated, some minor changes
- Some technical wording has been aligned to meet OMHA standards and policies
- It has been uploaded to pecmha website

Coach Mentor Position

- A new addition to our association is the position of coach mentorship
- Onboarding coaches, assisting with training, practice plans, coaching support, etc
- A full job description has been approved and Rob Garden has been appointed for this position
- At this point, not an executive position

House League Program

- U8 & U9 will be house league program, not LL (combined league)
- Numbers in those age groups are low, mainly due to travel and half ice at that age group
- We have to have a HL and LL in that age division in to order to run a U9 MD
- Question: What is the schedule looking like? U7 will be similar to Intro to hockey- learn to play program. Players can be evaluated to play up into house league program.
- Discussion took place,
- Depending on numbers at registration, we will see if we can field a LL and HL.

U16 Rep Update

- OHF released a statement after borders were opened, for the 2025/26, that all associations must have only the teams that they had for the 2024/25 season.
- Associations were given a small window of opportunity to apply to add additional teams with a written submission to support why this was wanted. January 26, 2025 was the deadline.
- There is currently no U16 division in the EOMHL so it was never a topic of conversation with the executive
- We were approached after the deadline about the desire to apply for a U16 team
- Krisitina did ask Suzanne (Regional Director) if it was possible to still apply. She was told we would have to wait until Sept to see if we had: 1. Enough players to support U18/U16 and U18LL. 2. If there were enough teams to create a division
- Side note a new Regional Director would be taking over in June so discussion would have to be with him once he takes over the position
- Further discussion took place-
- Topic tabled until Sept 2025

Ice Fee Increase

- 5% increase to price of ice this year
- Increase rep fees

Start Date in the Fall

- Potentially may not have August ice in Wellington
- We have asked for last 2 weeks of August

Championship Banners to be hung this summer

- They have been collected and ready to hang up this summer

Increased "Kings" signage in arenas

- Will be put up this summer
